

## **GSO Senate Resolution 24.13**

## A Resolution Reregulating RGSO & Special Programming Budget Practices

**Whereas**, the 56<sup>th</sup> GSO Senate and Executive Board have committed to pursuing reasonable cuts and regulations that promote fiscal responsibility and the effective distribution of the graduate student activity fee,<sup>1</sup> including registered graduate student organization (RGSO) budget and Special Programming policies;<sup>2</sup> and,

**Whereas**, the Executive Board has reviewed the RGSO budget and Special Programming regulations outlined in the GSO Fiscal Policy (such as those considered below, though not exhaustively)<sup>3</sup> and have determined that the following clarifications and updates would grant the GSO greater financial flexibility and promote responsible financial planning at both the GSO and RGSO levels; therefore be it,

**Resolved**, that the following Fiscal Policy regulations be adopted and added to or amended in the GSO Fiscal Policy, RGSO Handbook, and in all other places in which GSO Fiscal Policy regarding RGSO budgets & Special Programming are communicated (e.g. the GSO Website):

- 1. Academic (Departmental) RGSOs include only those representing all verified graduate student members of an academic department or program (or multiple academic departments or programs) at Syracuse University. These RGSOs should facilitate the election and maintenance of Academic Plan Senators for their associated department(s), as required to access funds.<sup>4</sup>
- GSO Annual Budget allocations for Academic (Departmental) RGSOs shall be funded at the rate of \$25 per fee-paying graduate student.<sup>5</sup> No Academic (Departmental) RGSO shall receive these per capita annual budget funds for graduate students in departments and programs already covered by another Academic (Departmental) RGSO.
- 3. Honor Societies are Non-Academic (Non-Departmental) RGSOs.<sup>6</sup> GSO funds may not be used to pay for Honor Society dues.<sup>7</sup>

Programming need clarified and reinforced to ensure that the GSO Senate appropriately adjudicates funding requests and equitably distributes funds. ... Items under consideration include: 1) requiring RGSOs to use allocated budgets toward their special programming requests, 2) establishing tiered special programming request caps, 3) and strengthening the per capita rule when determining funding allotments."

- 4. GSO Annual Budget allocations shall be capped at \$2000 per Academic (Departmental) RGSO.<sup>8</sup>
- 5. RGSOs may not use their GSO budget allocations to supply grants (e.g., as conference travel grants in addition to the GSO PAC Grant program).
- RGSOs must use their GSO Annual Budget allocation toward Special Programming requests, excluding any portion of the RGSO's annual allocation already approved for use through the GSO expense pre-approval process.
- 7. RGSO expense pre-approvals shall not be granted (a) outside of the Fiscal Year in which the funds are to be used, (b) when the Finance Committee is out of Session, and (c) before the required number of RGSO officers successfully complete annual required RGSO Officer Training.<sup>9</sup> In sole exception to (b) of this rule, the Executive Board may grant RGSO expense pre-approvals when the Finance Committee is not in session if an RGSO's associated academic plan's degree requirements include mandatory summer sessions.
- 8. RGSO Special Programming requests primarily intended to facilitate the academic and professional development of graduates shall be capped at \$3000.<sup>10</sup>
- 9. RGSO Special Programming requests with a social purpose shall be capped at \$1000.<sup>11</sup>
- 10. The Finance Committee may recommend an RGSO Special Programming amount for Senate approval that is higher than the cap if, with reasonable estimation, the ratio of \$25 per fee-paying graduate student served produces a number higher than the associated cap.<sup>12</sup> In such a case, they may recommend up to the number

produced by the ratio, but no higher. Likewise, the Senate may approve an amount more than the cap up to the number produced by the ratio, but no higher. The Senate may only grant exception, i.e. approve an amount exceeding both the cap and the ratio, by Resolution with a <sup>3</sup>/<sub>4</sub> vote-by-roll.

- 11. The Finance Committee ought to lower the RGSO Special Programming amount recommended for Senate approval if the amount requested by the RGSO is higher than the number produced, with reasonable estimation, by the ratio of \$25 per fee-paying graduate student served, unless the RGSO makes a compelling case for an amount that is higher than the ratio but lower than the associated cap (especially regarding requests primarily intended to facilitate the academic and professional growth of graduate students).
- 12. On principle, RGSO Special Programming supported by GSO funds should be open to all fee-paying graduate students. The Finance Committee may deny Special Programming applications (or items therein) that do not adhere to this principle, subject to appeal.<sup>13</sup> The Comptroller must report all denied Special Programming requests at the next Regular Meeting of the Senate.
- 13. On principle, the GSO encourages departments and other university funding resources to earmark funds for graduate students, and we encourage the development of equitable cost-sharing relationships between the GSO, departments, and other university funding resources for the mutually beneficial support of their graduate students and the graduate student community.<sup>14</sup> The Finance Committee ought to pursue equitable cost-sharing negotiations with departments and other university funding resources regarding RGSO Special Programming requests.
  - a. The Finance Committee may suspend consideration of an RGSO Special Programming request to pursue such negotiations.
  - b. The Finance Committee may recommend a preliminary RGSO Special Programming amount for Senate approval that is enough to cover the request's urgent, time-sensitive expenses (e.g., speaker travel, venue reservation, *et cetera*) while pursuing such negotiations, which must be made explicit in the recommendation.
  - c. In the latter event (i.e., b), the Finance Committee, if it deems necessary, may move to amend the RGSO Special Programming request previously

*adopted* (i) at a Meeting after that in which the preliminary funds were awarded (ii) to recommend adding funds to (but not subtracting funds from) the RGSO Special Programming request in question. This may be motioned only once per preliminary RGSO Special Programming amount awarded. The preliminary amount awarded and the additional amount added together must not exceed the cap and/or ratio of \$25 per feepaying graduate student served pursuant the relevant stipulations and exceptions.

- d. In deliberations regarding a *motion to amend the RGSO Special Programming request previously adopted*, the Senate may not under any circumstances reduce the preliminary amount previously awarded by the Senate, though it may dispose of the additional amount recommended by the Finance Committee in usual fashion.
- 14. The Finance Committee may approve Start-Up Funding for newly registered RGSOs without a Senate vote and, at the committee's discretion, with or without an interview of the new RGSO's representatives. The Comptroller must report all Start-Up funding approved at the next Regular Meeting of the Senate. The Senate reserves the right to override decisions of the Finance Committee.<sup>15</sup>
- 15. The Vice President of Internal Affairs must alert the Comptroller when informing an RGSO that they have fallen out of good standing.<sup>16</sup>

## Appendix to the Resolution: Current State of GSO Fiscal Policy regarding RGSOs & Special Programming (Not Exhaustive)

While members of the Executive Board reviewed the entire set of policies regarding registered graduate student organizations (RGSOs) and Special Programming, the following items presented as particularly relevant to this Resolution:

- (1) Standing policy at present states that (a) at least 20% of the GSO's total operating budget must be allocated to RGSO programming split between RGSO-specific annual budget lines and Special Programming, and that (b) RGSO annual budget allocations shall be funded at \$25 per verified graduate student member, capped at \$5,000 for "academic" (i.e., departmental) organizations and at \$300 for nonacademic" (i.e., non-departmental) organizations, and that (c) RGSOs in goodstanding may apply for additional GSO funds through Special Programming twice a year, which may contain requests pertaining to more than one event/item.<sup>17</sup>
- (2) There are currently (a) no explicit regulations requiring RGSOs to use their annual budget allocations either at all or before requesting additional GSO funding, and (b) no explicit regulations requiring RGSOs to use their remaining annual budget allocations toward items in Special Programming requests that they submit,<sup>18</sup> and (c) no caps on Special Programming requests,<sup>19</sup> and (c) only vague and inconsistent guidelines purportedly inspired by the GSO's principles regarding the kinds of items and events to be funded and amounts to be rewarded.<sup>20</sup>

(3) The Comptroller is empowered to reallocate RGSO annual budget lines to Special Programming if an RGSO falls out of good standing for a duration of 14 days after the first Regular Meeting of the GSO Senate that Fiscal Year,<sup>21</sup> but there is currently no mechanism ensuring that the Comptroller is informed when an RGSO falls out of good standing, and the Comptroller is otherwise unable to reallocate funds dedicated to RGSOs that do not use their budgets or signal intent to use their budgets,<sup>22</sup> often resulting in significant amounts of unused funds left over at the end of the Fiscal Year that could have been dedicated to other items.

Overall, it is concluded that the GSO would gain greater financial flexibility, and would better ensure the equitable distribution of the graduate student activity fee, if GSO Fiscal Policy is updated with an eye toward (a) articulating clearer guidance for the GSO Finance Committee, Executive Board, and Senate to follow regarding RGSO budget and Special Programming deliberations, and toward (b) instituting regulations that set reasonable limits while also empowering members to both enforce policy and grant warranted exceptions in the distribution of GSO funds.
